<b>1. 2014 total taxable value.</b> Enter the amount of 2014 taxable value on the 2014 tax roll today. Include any adjustments since last year's certification; exclude one-third over-appraisal corrections from these adjustments. <b>2. 2014 tax ceilings and Chapter 313 limitations.</b>  A. Enter 2014 total taxable value of homesteads with tax ceilings. <p><b>13. Taxes refunded for years preceding tax year 2014.</b> Enter the amount of taxes refunded by the district for tax years preceding tax year 2014. Types of refunds include court decisions, corrections and payment errors. Do not include refunds for tax year 2014. This line applies only to tax years preceding tax year 2014.</p>	<p>\$55,304</p>
<p><b>14. Adjusted 2014 taxes with refunds.</b> Add Lines 12 and 13.</p>	<p>\$20,210,441</p>
<p><b>15. Total 2015 taxable value on the 2015 certified appraisal roll today.</b> This value includes only certified values and includes the total taxable value of homesteads with tax ceilings (will deduct in Line 17). <p><b>16. Total value of properties under protest or not included on certified appraisal roll.</b></p> <p>A. <b>2015 taxable value of properties under protest.</b> The chief appraiser certifies a list of properties still under ARB protest. The list shows the appraisal district's value and the taxpayer's claimed value, if any, or an estimate of the value if the taxpayer wins. For each of the properties under protest, use the lowest of these values. Enter the total value.</p> <p>B. <b>2015 value of properties not under protest or included on certified appraisal roll.</b> The chief appraiser gives school districts a list of those taxable properties that the chief appraiser knows about, but are not included at appraisal roll certification. These properties are not on the list of properties that are still under protest. On this list of properties, the chief appraiser includes the market value, appraised value and exemptions for the preceding year and a reasonable estimate of the market value, appraised value and exemptions for the current year. Use the lower market, appraised or taxable value (as appropriate). <b>20. Total 2015 taxable value of new improvements and new personal property located in new improvements.</b> New means the item was not on the appraisal roll in 2014. New additions to existing improvements may be included if the appraised value can be determined. New personal property in a new improvement must have been brought into the taxing unit after Jan. 1, 2014, and be located in a new improvement.	\$0
<b>21. Total adjustments to the 2015 taxable value.</b> Add Lines 19 and 20.	\$0
<b>22. 2015 adjusted taxable value.</b> Subtract Line 21 from Line 18.	\$1,370,279,731
<b>23. 2015 effective tax rate.</b> Divide Line 14 by Line 22 and multiply by \$100.	\$1.4749/\$100
<b>24. 2015 effective tax rate for ISDs with Chapter 313 Limitations.</b> Add together the effective tax rates for M&O and debt service for those school districts that participate in an applicable Chapter 313 limitations agreement.	\$0/\$100

<b>25. Maintenance and operations (M&amp;O) rate.</b> Enter \$1.50 OR the 2005 adopted M&O rate if voters approved a rate higher than \$1.50.	\$1.5000/\$100
<b>26. Multiply line 25 times 0.6667</b>	\$1.0000/\$100
<b>27. 2015 rollback M&amp;O rate.</b>  Use the lesser of the M&O rate as calculated in Tax Code Section 26.08(n)(2)(A) and (B).	\$1.0400/\$100
<b>28. Total 2015 debt to be paid with property tax revenue.</b> "Debt" means the interest and principal that will be paid on debts that: (1) Are paid by property taxes, (2) Are secured by property taxes, (3) Are scheduled for payment over a period longer than one year, and (4) Are not classified in the school district's budget as M&O expenses  A. Debt also includes contractual payments to other school districts that have incurred debt on behalf of this school district, if those debts meet the four conditions above. Include only amounts that will be paid from property tax revenue. Do not include appraisal district budget payments.  B. If using unencumbered funds, subtract unencumbered fund amount used from total debt.  C. Subtract state aid received for paying principal and interest on debt for facilities through the existing debt allotment program and/or instructional facilities allotment program.  D. <b>35. 2015 rollback tax rate.</b> Adds lines 27 and 34.	\$1.4610/\$100
